<b>REFUND POLICY</b>	Fees are non-refundable under any circumstances, including mid-term withdrawal.
<b>OVERDUE PAYMNETS</b>	All invoices must be paid by the due date stated on the invoice. <ul style="list-style-type: none"><li>• Any unpaid invoices will automatically incur a late fee of 15% of the total invoice amount.</li><li>• If an invoice remains unpaid for more than three (3) weeks, JDS reserves the right to suspend your child's enrolment until the invoice is paid in full.</li></ul>
